A COMPLETE SHOWROOM SALES ORDER AND PAYMENT IN FULL FOR GOODS AND APPLICABLE SALES TAX ARE REQUIRED TO SECURE AVAILABLE INVENTORY. IN-STOCK TABLES AND LAMPS SHIP ACCORDING TO GP'S EXISTING POLICIES AND PROCEDURES FOR SHIPPING. GP WILL ENGAGE A SHIPPER ON THE CUSTOMER'S BEHALF, OR ITEMS CAN BE COLLECTED BY CUSTOMERS AS "WILL CALL" SHIPMENTS.  - DELIVERY ADDRESS
 - PHONE NUMBER AT DELIVERY ADDRESS
 - ADDRESS FOR FINAL INSTALLATION LOCATION (IF DIFFERENT THAN DELIVERY ADDRESS - FOR CALCULATION OF APPLICABLE SALES TAX)
 - INFORMATION REQUIRED FOR "WILL CALL" SHIPMENTS
 - SHIPPER/CARRIER'S NAME
 - ADDRESS FOR FINAL INSTALLATION LOCATION (FOR CALCULATION OF APPLICABLE SALES TAX)

PAYMENT IN FULL DEFINITION

- DEFINITION FOR "WILL CALL" SHIPMENTS:
 - 100% PAYMENT FOR GOODS AND SALES TAX (IF APPLICABLE)
- DEFINITION FOR SHIPMENTS USING A GP-ENGAGED SHIPPER:
 - 100% PAYMENT FOR GOODS AND SALES TAX (IF APPLICABLE)
 - PAYMENT FOR FREIGHT CHARGES:
 - REPLIES TO FREIGHT QUOTE REQUESTS CAN TAKE UP TO THREE BUSINESS DAYS. AN INITIAL PAYMENT FOR GOODS AND SALES TAX CAN BE SUBMITTED TO SECURE INVENTORY, AND A SECOND PAYMENT FOR FREIGHT CAN BE SUBMITTED ONCE THE FREIGHT CHARGES ARE QUOTED.
- SALES TAX:

PROCESSING TIME

- PRODUCTS WILL BE RELEASED TO THE GP-ENGAGED SHIPPER OR WILL BE AVAILABLE FOR “WILL CALL” RELEASE 48-72 HOURS FROM RECEIPT OF A COMPLETE ORDER AND PAYMENT.
 - THE GP-ENGAGED SHIPPER REQUIRES AN ADDITIONAL 48-72 HOURS FOR PACKING. GOODS SHOULD LEAVE THE SHIPPER 4-6 DAYS AFTER RECEIPT OF PAYMENT IN FULL.
 - CUSTOMER’S SHIPPING/DELIVERY SERVICE FOR “WILL CALL” SHIPPING MUST CALL 310.204.0400 AND SPEAK TO AN ACCOUNT MANAGER 24 HOURS BEFORE PICK-UP FROM OUR WAREHOUSE LOCATED AT 502 N. OAK STREET, INGLEWOOD, CALIFORNIA 90302
